THE JAMMU AND KASHMIR APPROPRIATION BILL, 2020

A

BILL

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Jammu and Kashmir for the services of the financial year 2019-20.

BE it enacted by Parliament in the Seventy-first Year of the Republic of India, as follows:—

1. This Act may be called the Jammu and Kashmir Appropriation Act, 2020. Short title.
2. From and out of the Consolidated Fund of the State of Jammu and Kashmir, Issue of

3. The sums authorised to be paid and applied from and out of the Consolidated Appropriation.
Fund of the State of Jammu and Kashmir by this Act shall be appropriated for the
services and purposes expressed in the Schedule in relation to the said year.

This Bill is introduced in pursuance of the Gazette of India, Extraordinary, Part II, Section 3, sub-section (ii), S.O. 3938(E), dated the 31st day of October, 2019 issued consequent upon the proclamation issued on the 31st day of October, 2019, Gazette of India, Extraordinary, Part II, Section 3, sub-section (ii), S.O. 3937(E), dated the 31st day of October, 2019 under section 73 of the Jammu and Kashmir Reorganisation Act, 2019 read with articles 239 and 239A of the Constitution and section 74 of the Jammu and Kashmir Reorganisation Act, 2019, to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the State of Jammu and Kashmir of the moneys required to meet the supplementary expenditure to regularise the sum withdrawn in excess of grant for the financial year 2019-20 for the period from the 1st day of April, 2019 to the 30th day of October, 2019.
